2011 Census: ward level population and household estimates revised

1 Introduction

- 1.1 On Friday 23 November 2012 the Office for National Statistics (ONS) released population and household estimates both at ward level and census output area (OA) level. This was the final phase of the first release of 2011 Census data.
- 1.2 An initial briefing based on ONS ward level population and household estimates, was issued by Oldham's Corporate Research and Intelligence Team that day.
- 1.3 This briefing paper re-presents the 2011 Census population estimates at ward level, comparing these to the 2001 Census estimates. It complements the 2011 Census: First Oldham Analysis briefing paper¹ which reported on the initial release of rounded population and household estimates at Local Authority level, and the subsequent Ward level statistics for Oldham² which compared other 2011 Census variables with those from the 2001 Census at ward level.
- 1.4 2011 Census household estimates are again presented at ward level and compared to 2001 Census estimates. The Census estimates are also compared to numbers of occupied households taken from the February 2011 reconciliation of extracts from Oldham Council's Local Land and Property Gazetteer (LLPG) and Council Tax (CTAX) system.
- 1.5 This briefing uses re-apportioned population and household estimates at ward level rather than those produced by the ONS best-fit methodology from the 2001 and 2011 Census. These are considered to give more accurate results as they are based on numbers of occupied households in each ward (from Oldham Council administrative systems) at the time of the Census.
- 1.6 Maps are provided showing the percentage change in the estimates of overall population and household numbers between 2001 and 2011 at lower super output area (LSOA) level.

2 Background

- 2.1 The Census took place on 27 March 2011.
- 2.2 There were a small number of changes to Census geographies at OA and LSOA level. These were in the main to keep within ONS thresholds for population and household numbers. In a few cases ONS amended the geographies in consultation with Local Authorities. Oldham now has 141 LSOAs, whilst previously we had 144. A forthcoming briefing will describe how these changes affect Oldham.

- 2.3 When ONS created the OA geography for the 2001 Census, all OAs nested within the then existing wards. Along with other Greater Manchester Local Authorities, Oldham subsequently underwent a ward boundary review implemented in 2004. In the few cases where OAs cross the 2004 ward boundaries, ONS apply a best-fit methodology when aggregating to ward level.
- 2.4 The Corporate Research and Intelligence Team investigated how the ONS best-fit methodology compared to the method Oldham Council currently uses. It was concluded that the re-apportioned OA level data (based on known numbers of occupied households) gave more reliable ward level estimates for Census data. Additionally this is consistent with the re-apportioning applied to generate ward level figures from other data released more regularly at OA and LSOA level.

3 Summary of findings

Population

- 3.1 The estimated population in Oldham grew between censuses increasing from 217,273 in 2001 to 224,897 in 2011, a 3.5% increase.
- 3.2 The increase in the overall estimated population across Greater Manchester was 8.1% and was 7.9% for England. These increases were larger than in Oldham.
- 3.3 In most of Oldham's 20 wards, there has been an increase in estimated population numbers between the 2001 and 2011 censuses. The largest increases have been in St. Mary's (15.1%) and Coldhurst (10.8%). In six wards population numbers have decreased. The largest percentage decreases have been in Crompton (-4.2%), along with St. James' (-3.5%) and Royton North (-2.9%).
- 3.4 There was a greater increase in the estimated number of men than there was of women. The estimated male population in Oldham rose from 105,036 in 2001 to 110,155 in 2011 (a 4.9% increase). This was more than twice the 2.2% increase for the estimated female population in Oldham which rose from 112,237 in 2001 to 114,742 in the 2011 Census.
- 3.5 This gender difference was also reflected beyond Oldham. Greater Manchester saw 9.7% and 6.5% increases, whilst England as a whole saw 9.0% and 6.8% increases in the estimated male and female population respectively.
- 3.6 The gender difference at ward level is most marked in Alexandra, Coldhurst and Medlock Vale. In Alexandra the number of males increased by 12.6% and females by 5.1%. The increases in Coldhurst were 14.3% and 7.3%, and 10.7% and 6.3% in Medlock Vale respectively. Waterhead has seen a 3.5% increase in population overall equal to the Oldham average, yet numbers of males have increased by 6.1% and females by only 1.1%.

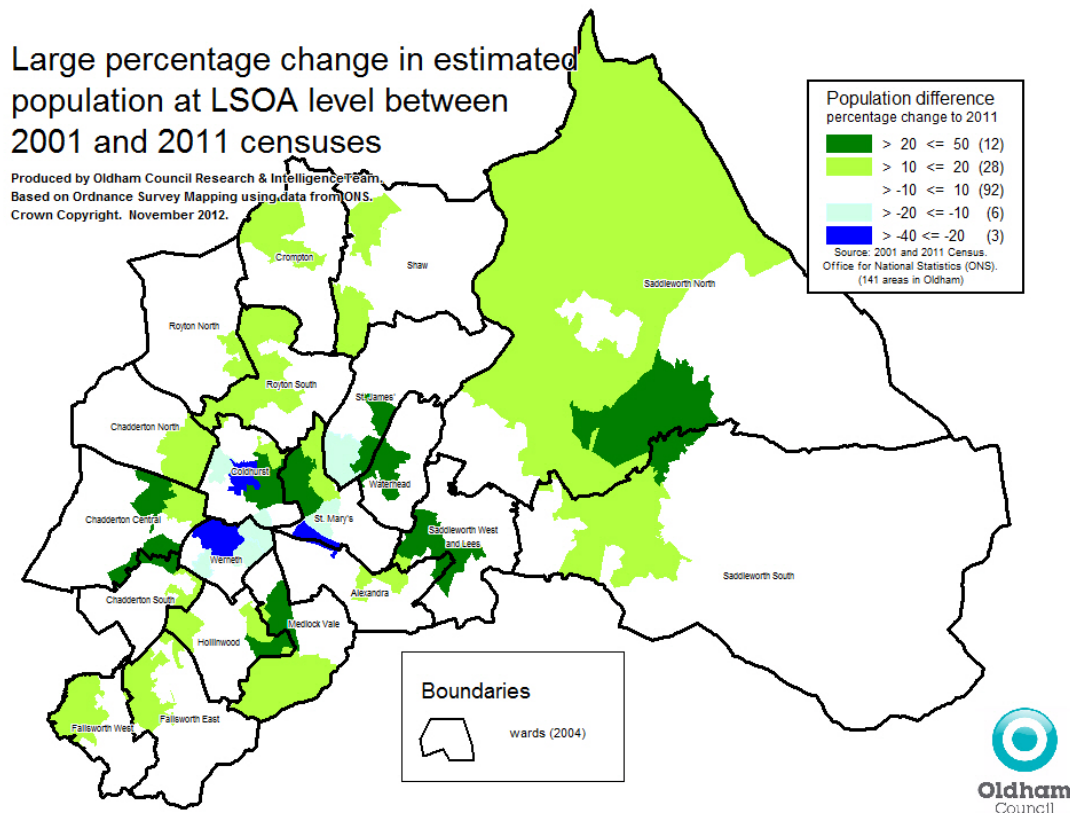

3.7 Average population density in Oldham is 15.8 (people per hectare of land). This is nearly four times the average for England (4.1). The Greater Manchester average is 21.0. As would be expected, population density varies greatly by ward in Oldham. It is highest in Werneth (66.4), Coldhurst (58.2), Waterhead (52.4) and St. Mary's (51.2). It is lowest in Saddleworth North (2.3) and Saddleworth South (3.0).

The map below shows population change at Lower Super Output Area level, highlighting those areas where change between the 2001 and 2011 Censuses has been greatest.



Households

- 3.8 The estimated number of households with at least one usual resident also increased in Oldham between 2001 and 2011, from 87,824 to 89,703 (an increase of 2.1%).
- 3.9 The 2011 Census estimate of 89,703 households is close to the figure of 89,472 households with at least one usual resident derived from the reconciliation of data extracts from Oldham Council's LLPG and CTAX systems in February 2011.
- 3.10 In most of Oldham's 20 wards, there has been an increase in the number of households between the 2001 and 2011 censuses. The largest increases have been in Saddleworth South (10.0%), Saddleworth West and Lees (7.4%) and St. Mary's (6.7%). In five wards the number of households has decreased. The largest decreases have been in Werneth (-9.4%) and St. James' (-5.4%) due to demolitions as part of the Housing Market Renewal programme.

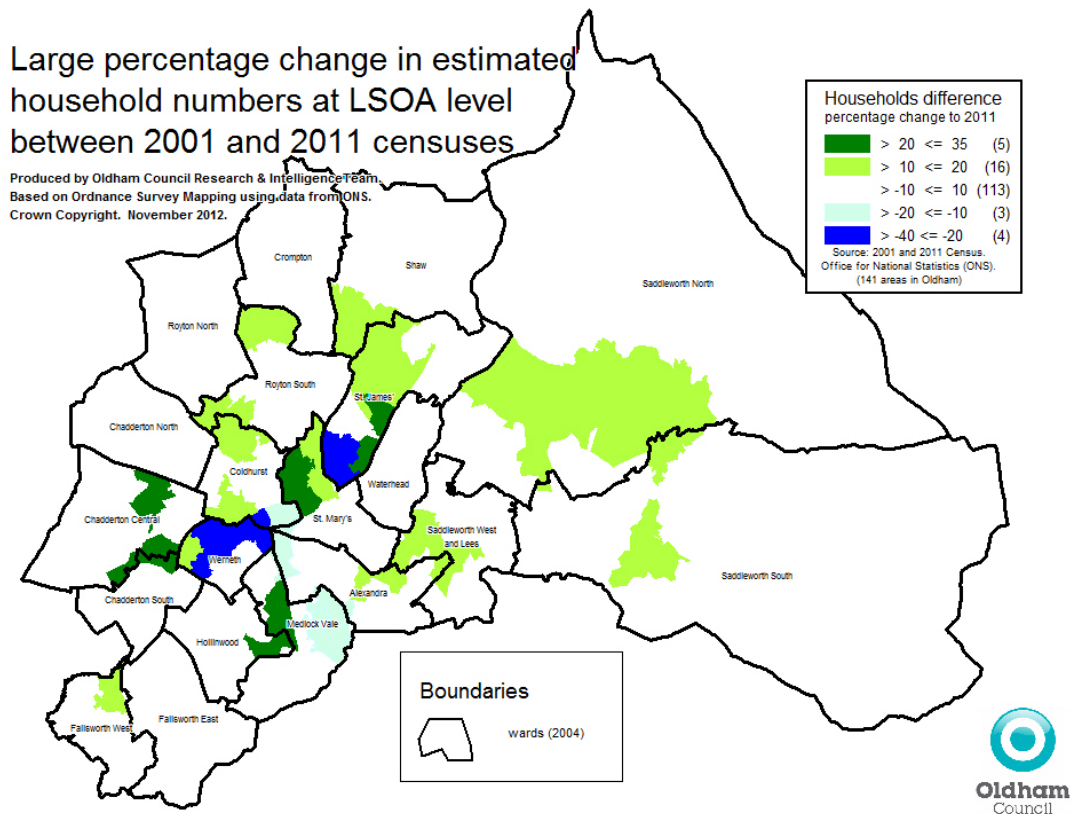

3.11 The average household size in Oldham is 2.5, higher than the Greater Manchester and North West averages (both 2.3) and the England average (2.4). Average household size is highest in Werneth (3.4), St. Mary's (3.2) and Coldhurst (3.1). Nine wards have a household size of 2.3, the lowest in Oldham.

4 Policy implications

- 4.1 The latest 2011 Census results highlight ward-level variation in Oldham's age structure. Further analysis will be undertaken at lower levels of geography. Such information is central to informing the location of age-related services and facilities such as schools, youth centres, different types of health and social care services and sheltered accommodation.
- 4.2 Average household size in three Oldham wards (Coldhurst, St. Mary's and Werneth) is greater than 3. This is significantly above the Oldham average (2.5), the regional average (2.3) and national average (2.4) suggesting there may still be issues of overcrowding to be addressed.

5 Next steps

- 5.1 Further analysis will be undertaken of 2011 Census data including age structure at lower levels of geography, patterns of change by gender and population density.
- 5.2 ONS began the first phase of the second release on 11 December 2012 with all key statistics and some quick statistics at local authority level. On 30 January 2013, ONS issued all Key and Quick statistics for various geographies covering ethnic group, housing, economic activity, qualifications, health and disability amongst others. More detailed data began to be released in March 2013 and the fourth release including OA level data began in July 2013. As mentioned in the introduction, a report³ published in May 2013 compared 2011 Census variables with those from the 2001 Census at ward level. Further briefings will be produced as soon as possible.

6 Ward level population and households estimates by age and sex

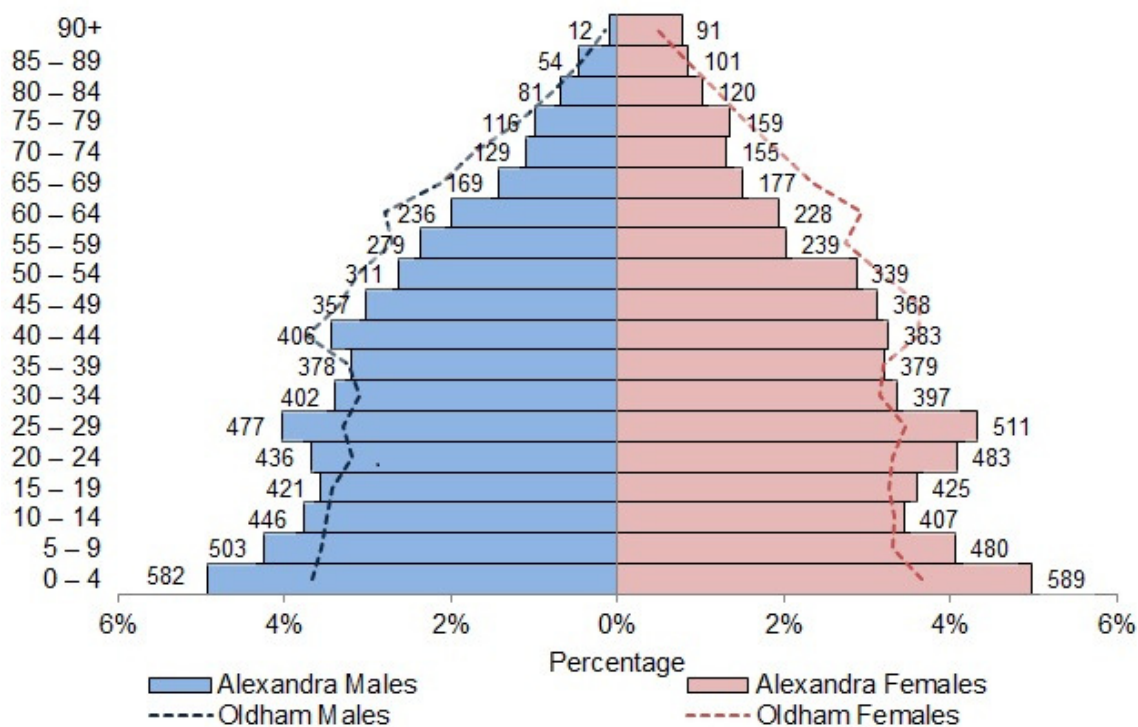
- 6.1 This section of the Briefing Note presents tables and population pyramids by five-year age-band and sex for all wards in Oldham, compared to the Oldham average. The table shows the sex composition of each five-year age-band. Bars on the population pyramids show the five-year age-band and sex as a percentage of the total ward population, comparable Oldham-wide figures are shown as dashed lines. Ward population numbers are also shown on the pyramids.
- 6.2 The tables and pyramids clearly show the differing age-structures of wards. Coldhurst, St. Mary's and Werneth all have particularly marked younger age structures, with higher proportions of younger people and lower proportions of older people than Oldham-wide. Crompton, Royton North, Saddleworth South and Saddleworth North all have relatively older age structures.

Figure 1: Age composition of Alexandra and Oldham compared (Census 2011)¹

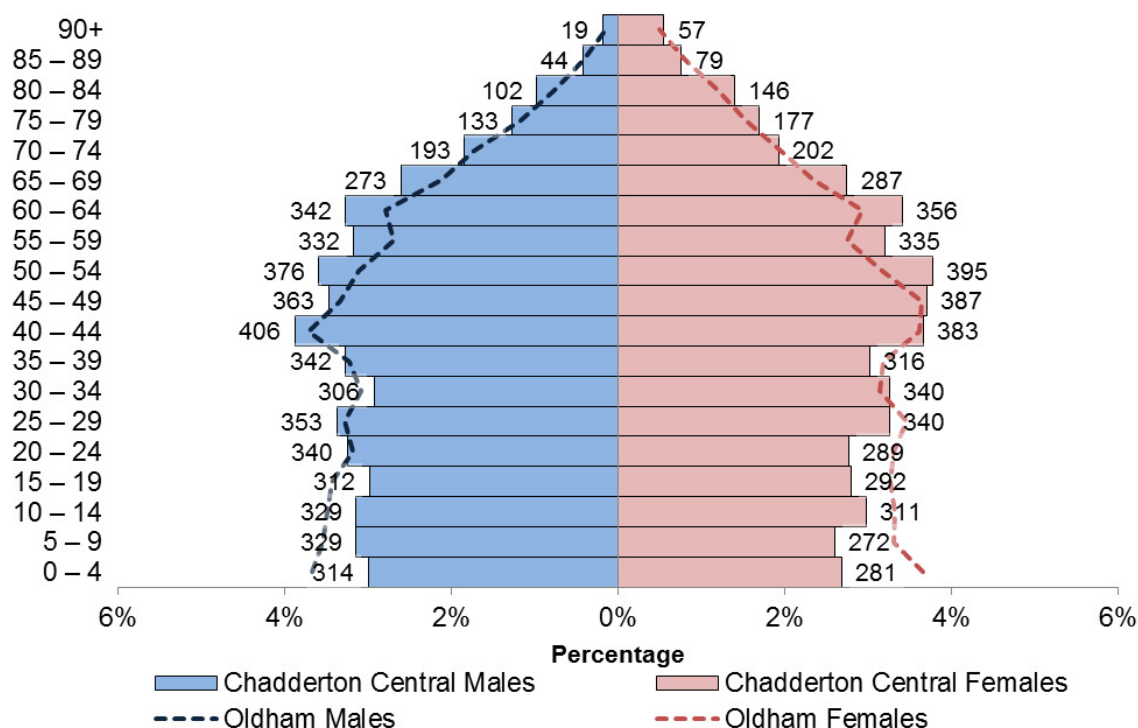

Figure 2: Age composition of Chadderton Central and Oldham compared (Census 2011)¹

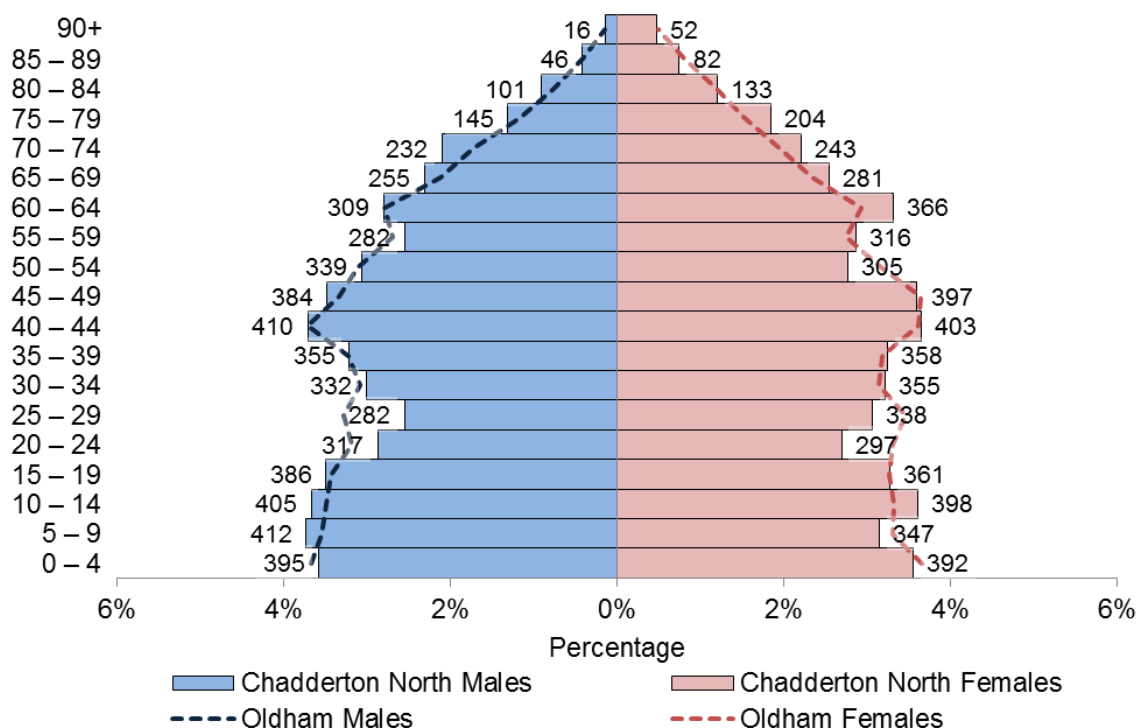

Figure 3: Age composition of Chadderton North and Oldham compared (Census 2011)¹

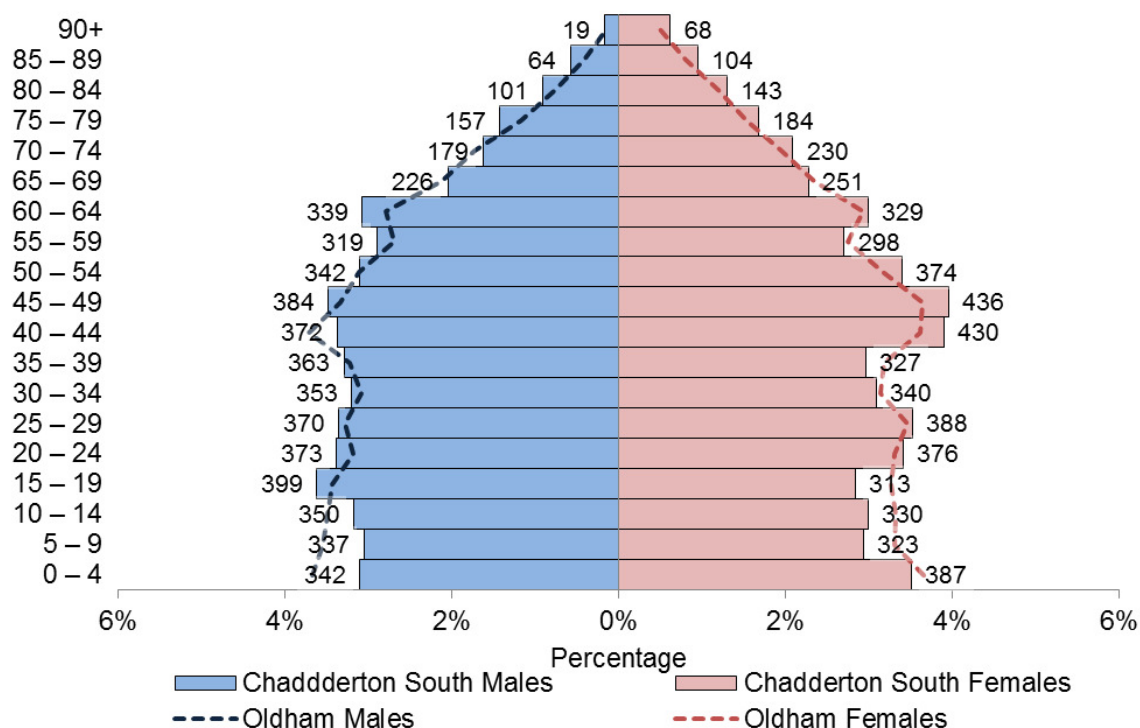

Figure 4: Age composition of Chadderton South and Oldham compared (Census 2011)¹

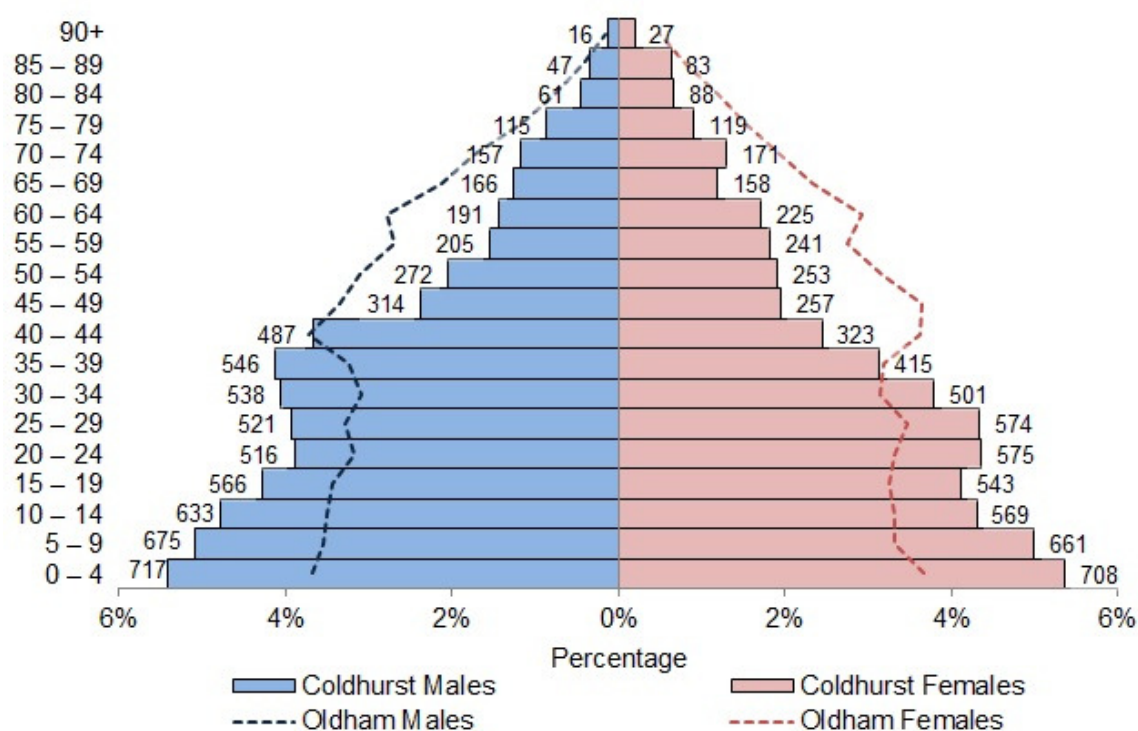

Figure 5: Age composition of Coldhurst and Oldham compared (Census 2011)¹

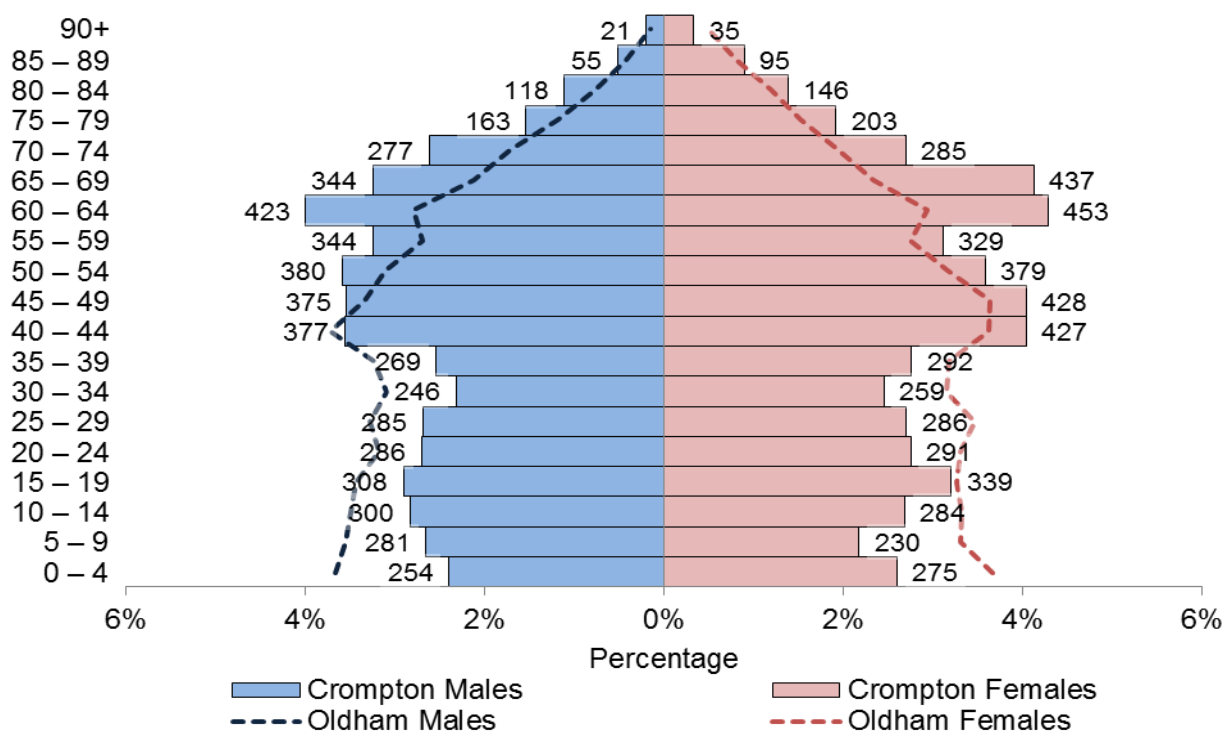

Figure 6: Age composition of Crompton and Oldham compared (Census 2011)¹

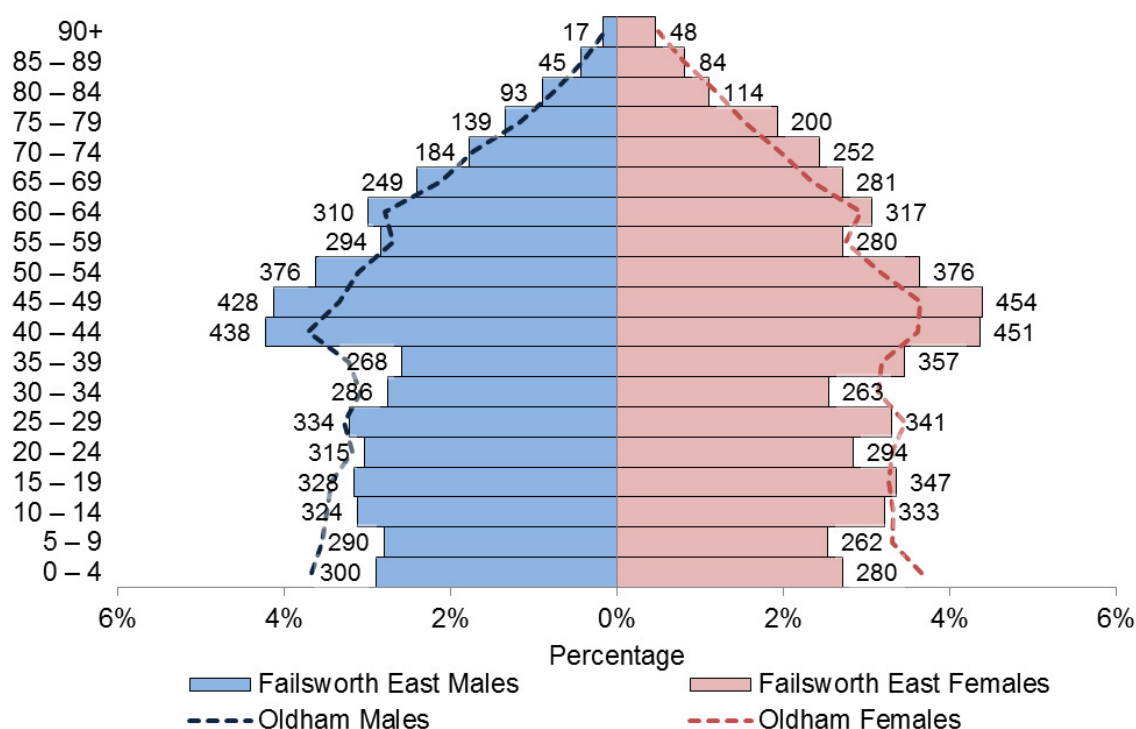

Figure 7: Age composition of Failsworth East and Oldham compared (Census 2011)¹

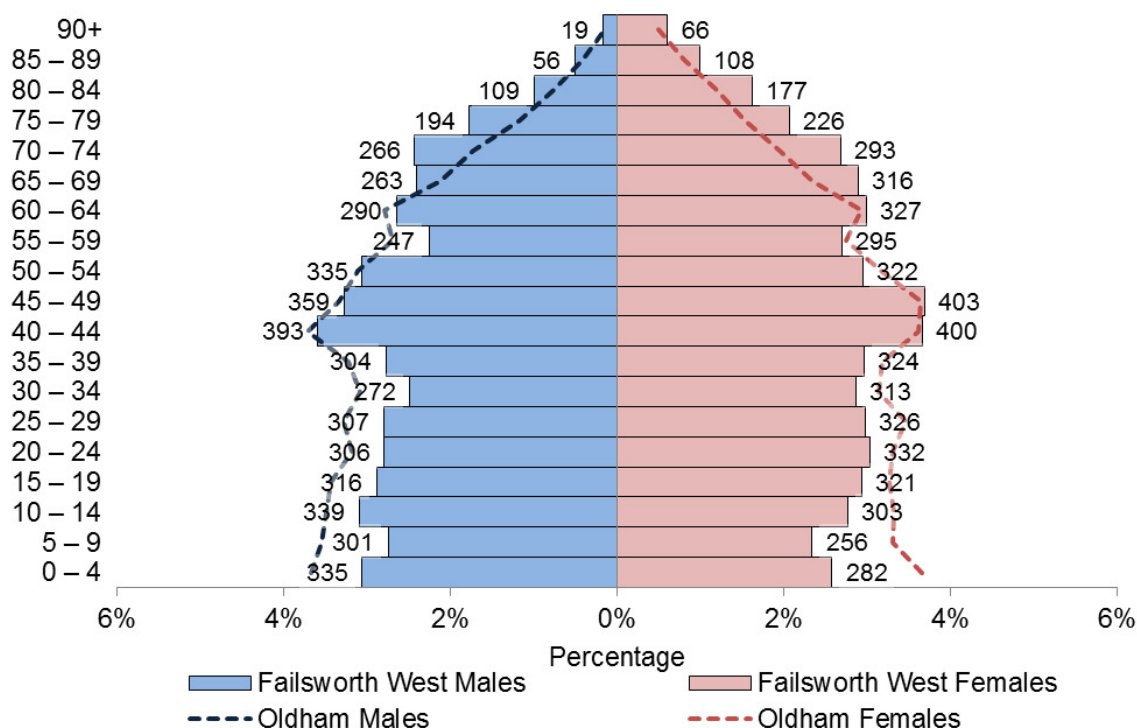

Figure 8: Age composition of Failsworth West and Oldham compared (Census 2011)¹

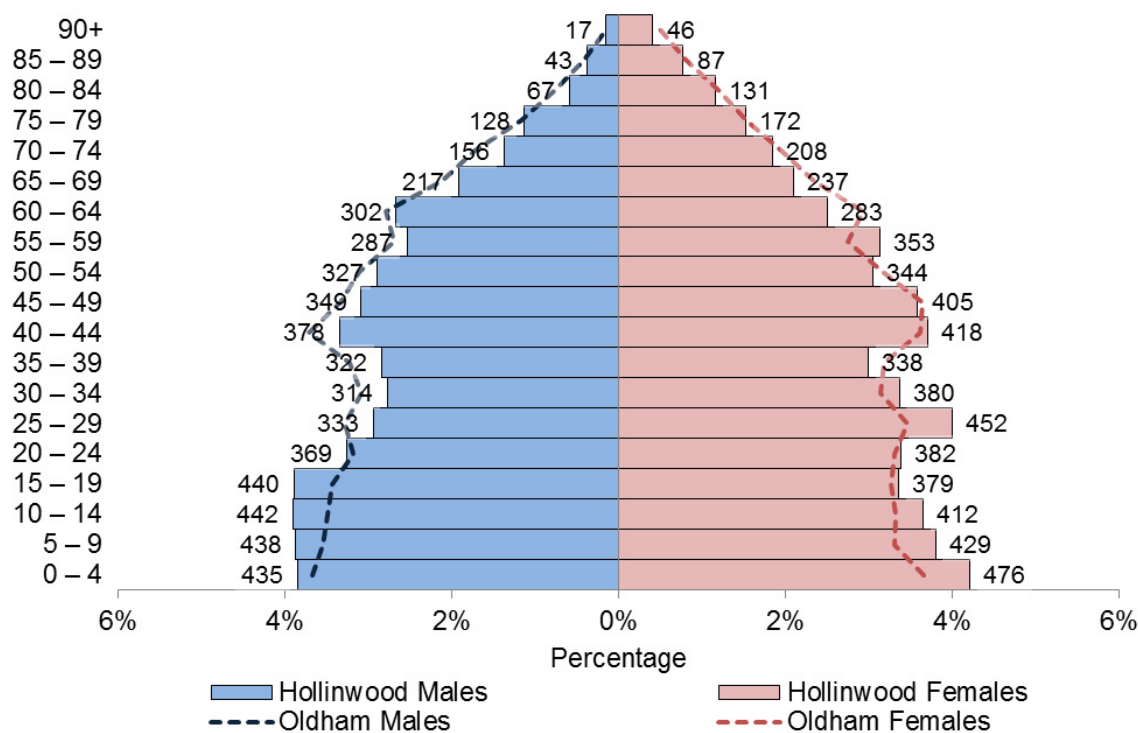

Figure 9: Age composition of Hollinwood and Oldham compared (Census 2011)¹

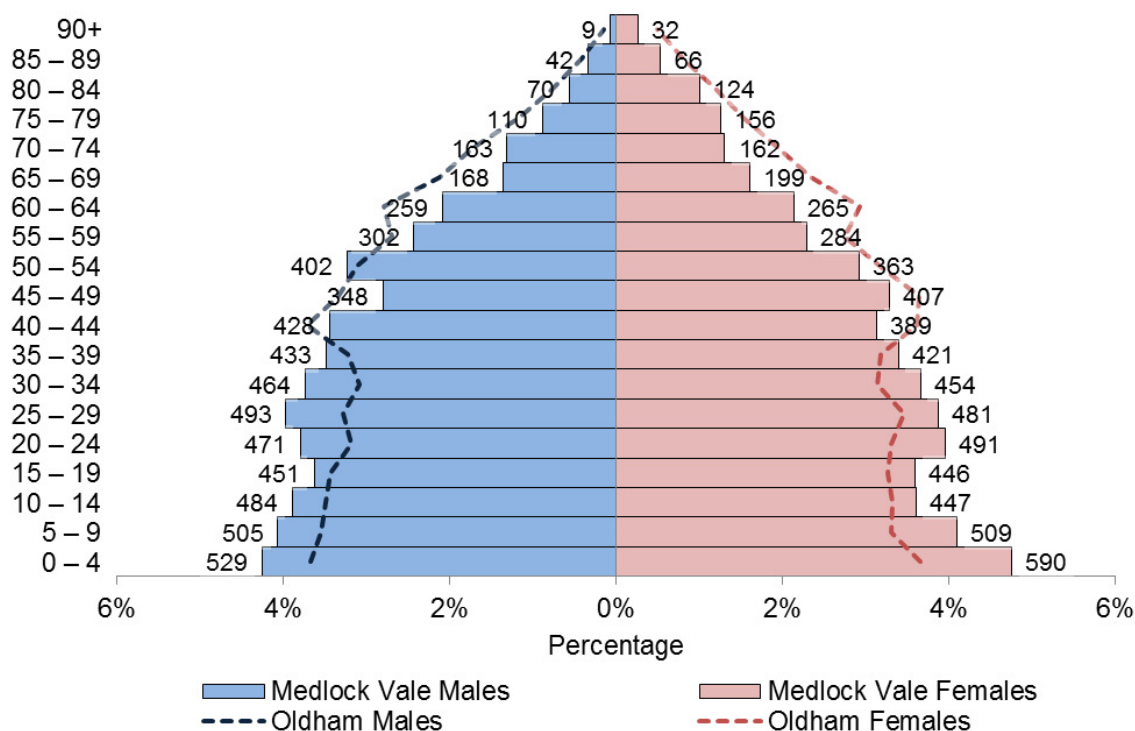

Figure 10: Age composition of Medlock Vale and Oldham compared (Census 2011)¹



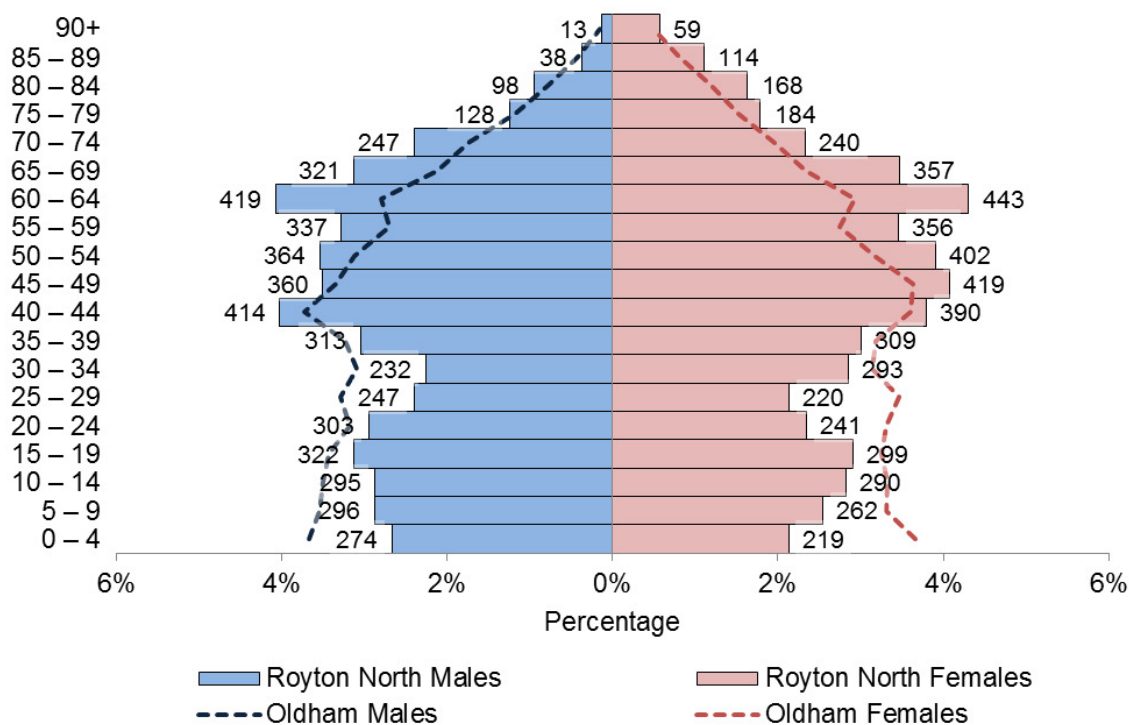

Figure 11: Age composition of Royton North and Oldham compared (Census 2011)¹

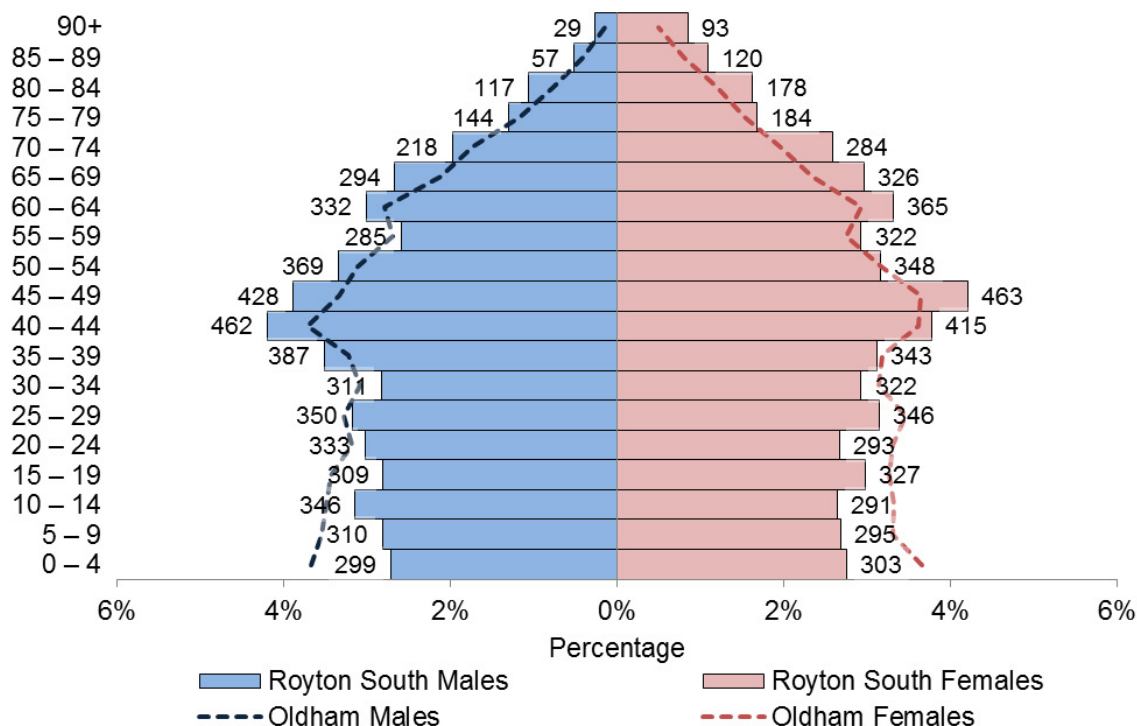

Figure 12: Age composition of Royton South and Oldham compared (Census 2011)¹

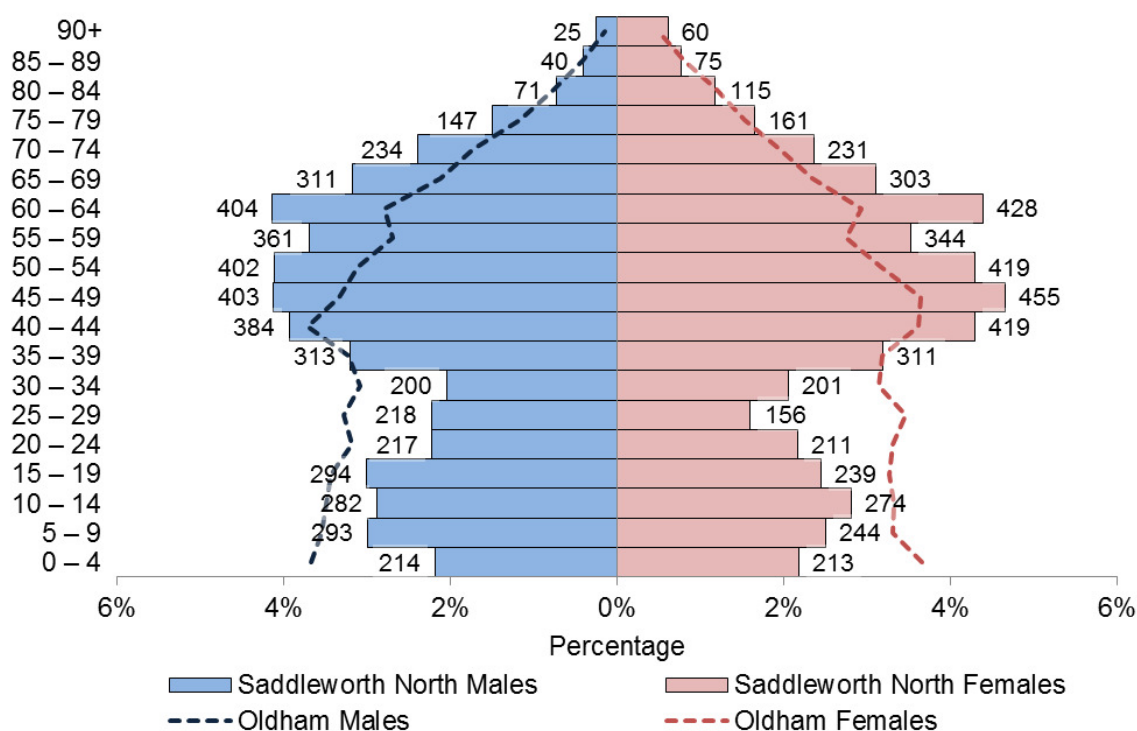

Figure 13: Age composition of Saddleworth North and Oldham compared (Census 2011)¹

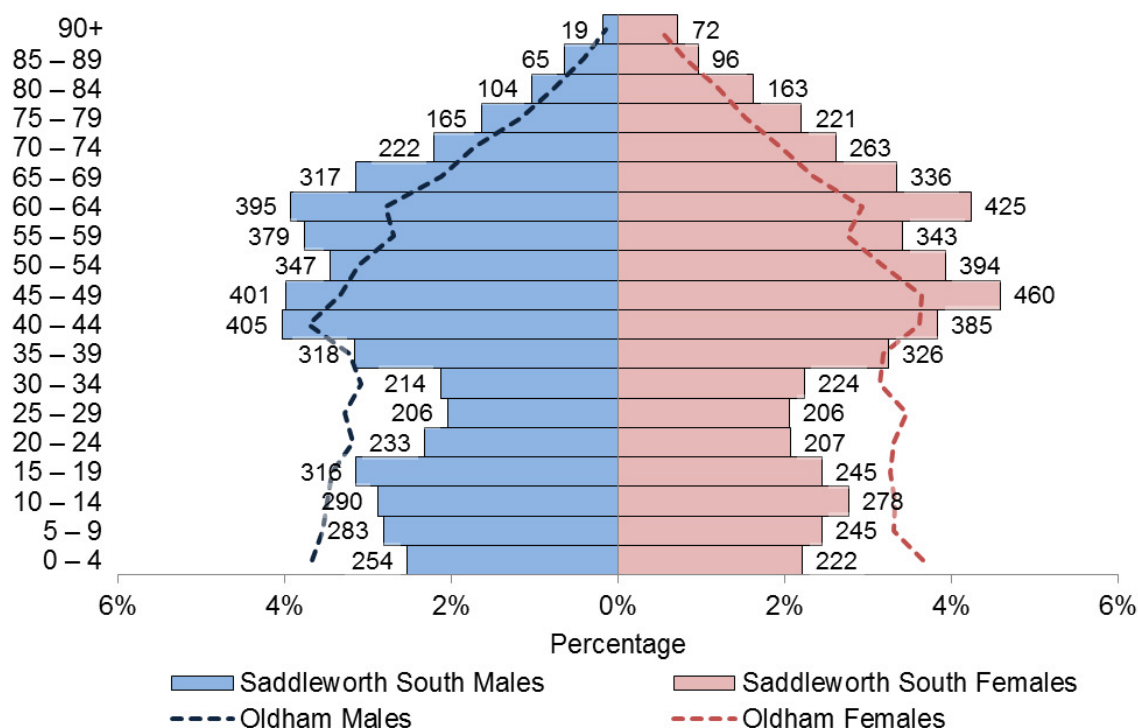

Figure 14: Age composition of Saddleworth South and Oldham compared (Census 2011)¹

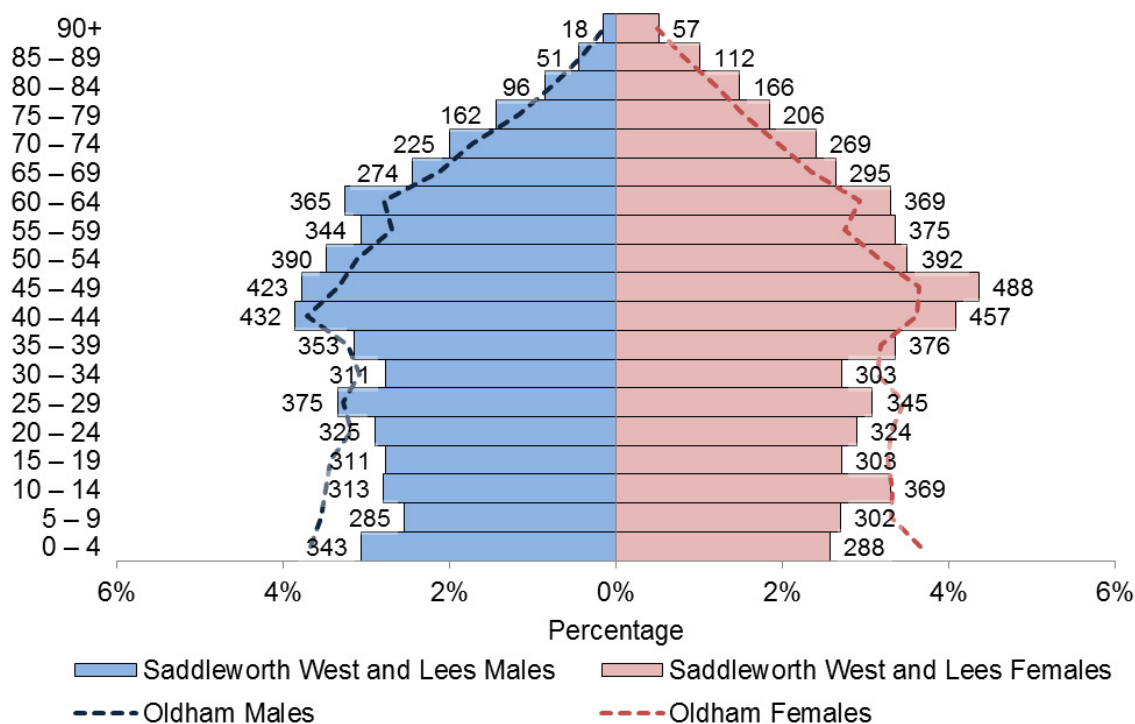

Figure 15: Age composition of Saddleworth West and Lees and Oldham compared (Census 2011)¹

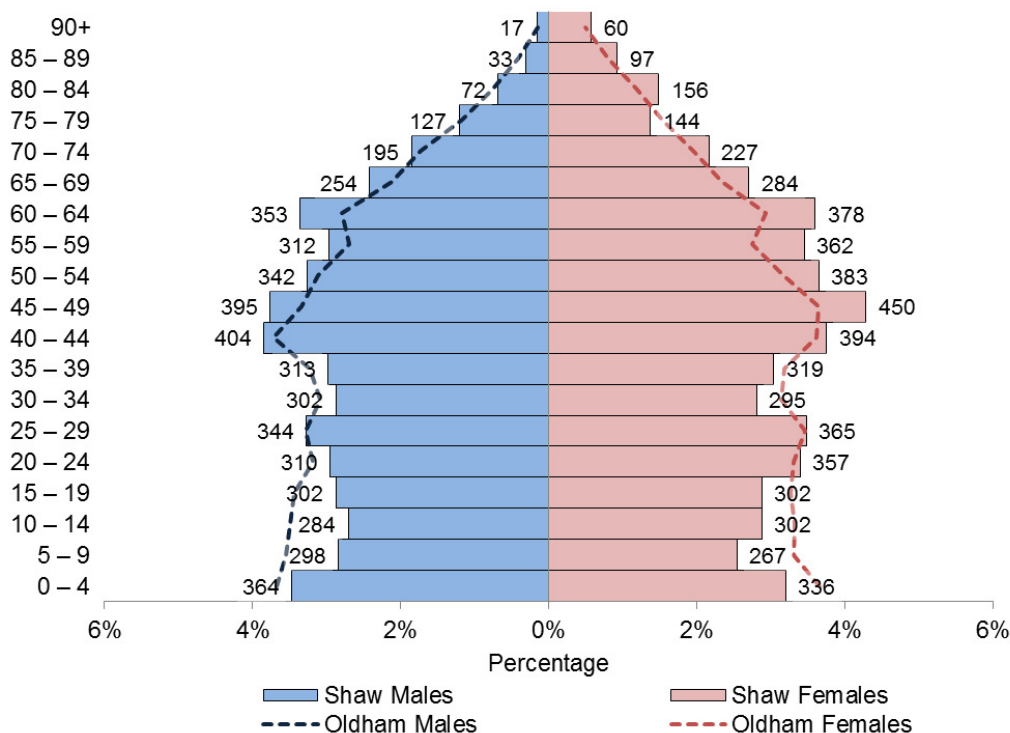

Figure 16: Age composition of Shaw and Oldham compared (Census 2011)¹

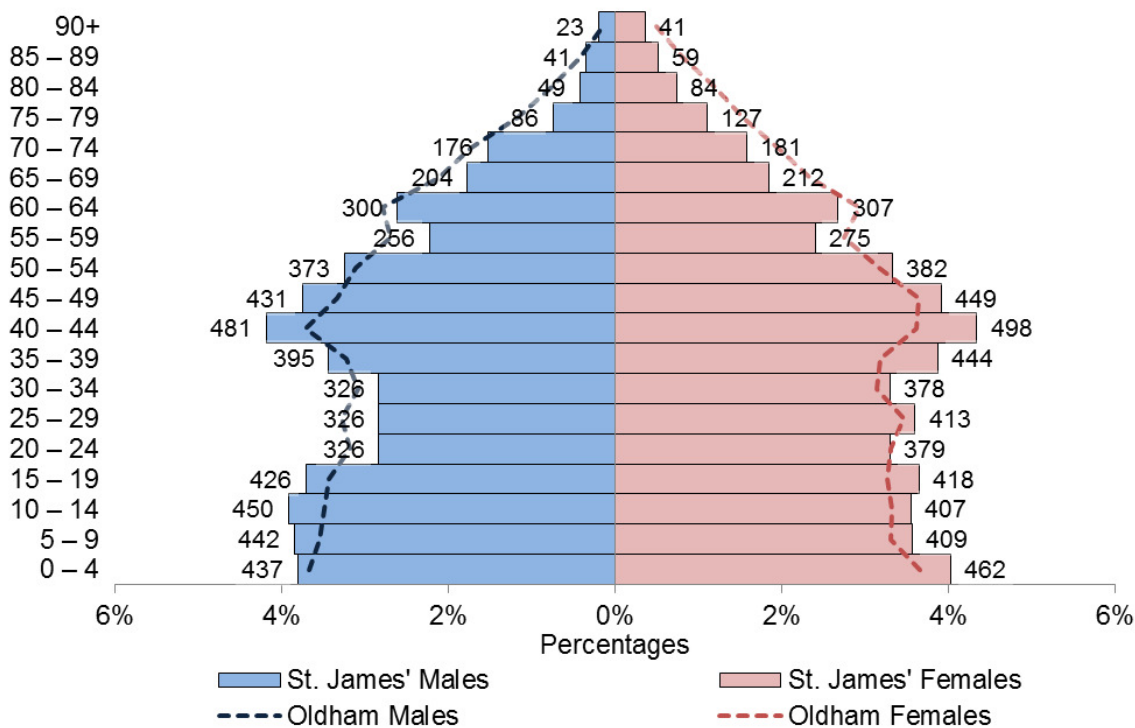

Figure 17: Age composition of St. James' and Oldham compared (Census 2011)¹

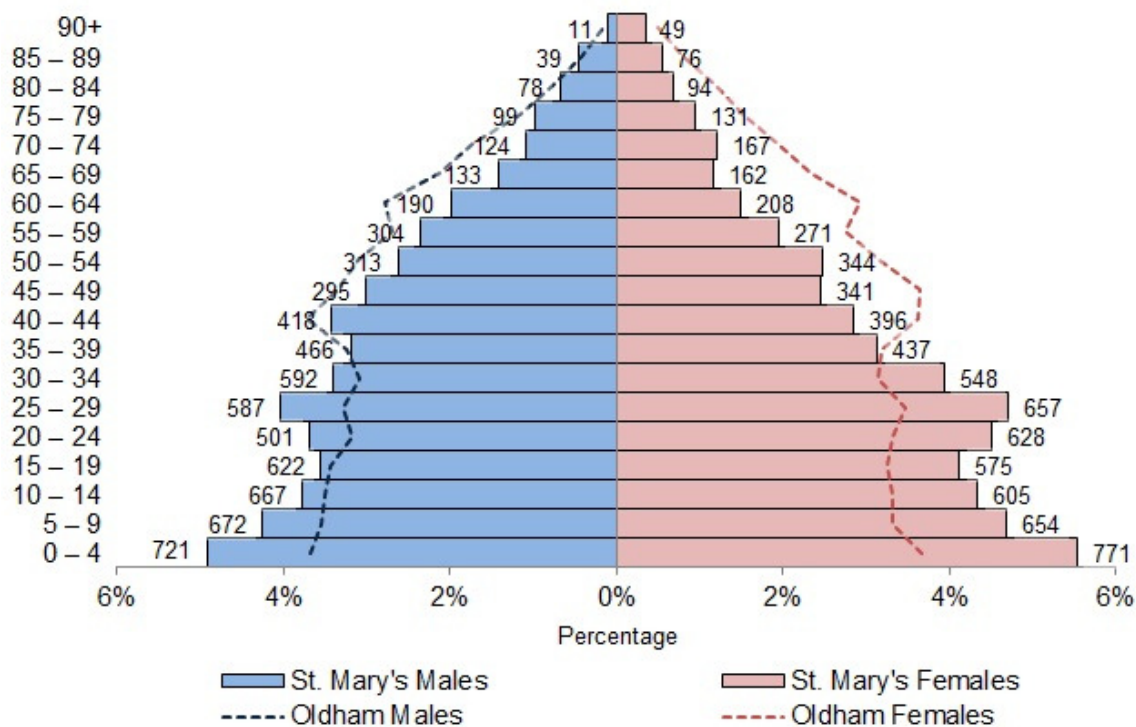

Figure 18: Age composition of St. Mary's and Oldham compared (Census 2011)¹

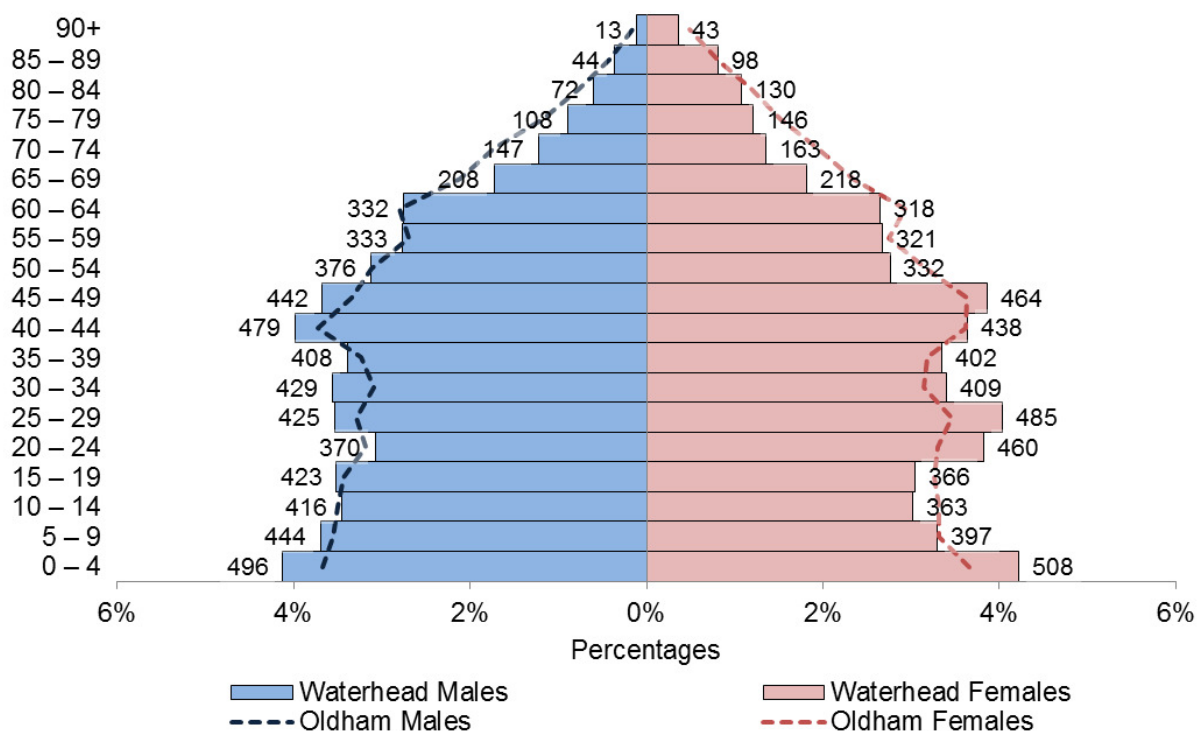

Figure 19: Age composition of Waterhead and Oldham compared (Census 2011)¹

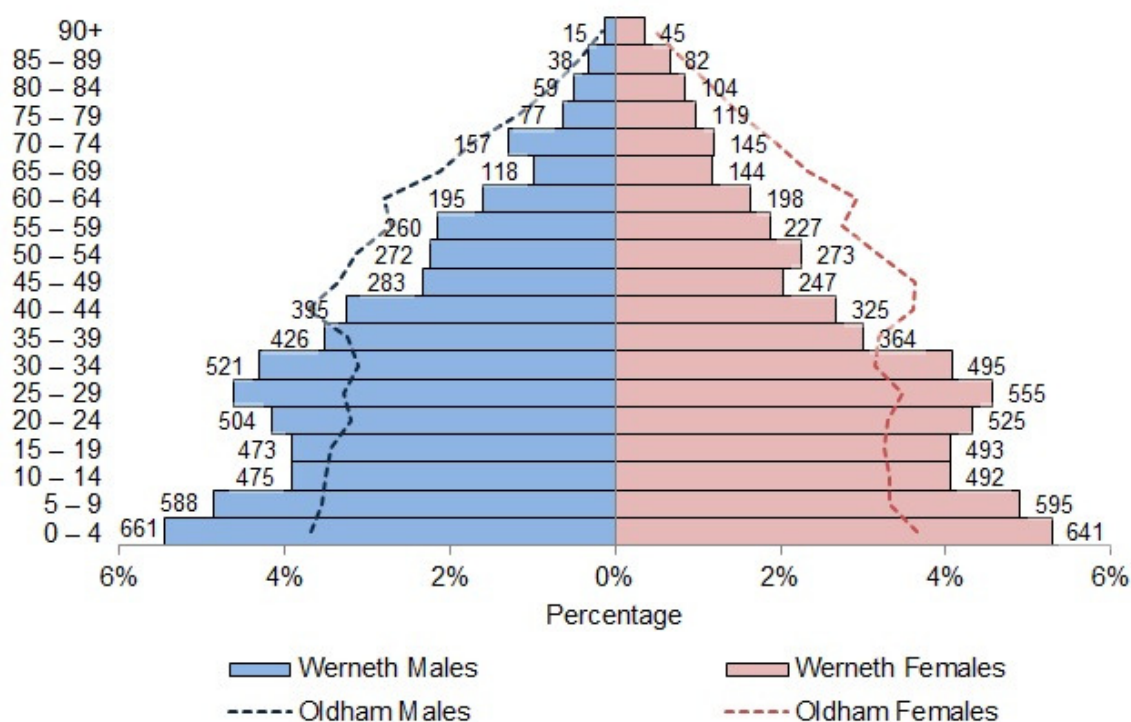
