**Oldham Council - Local Development Framework
Review Statement of Community Involvement - Adoption Statement**

Notice is hereby given that Oldham Council adopted the Review Statement of Community Involvement (SCI) on 21 July 2010. The SCI sets out how the council will involve the community in the preparation of the Local Development Framework and in the consideration of planning applications. Copies of the SCI will be available for inspection at the Civic Centre, Oldham Business Centre, all public libraries and on the council's website at www.oldham.gov.uk.

Any person aggrieved by the SCI may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the grounds that the document is not within the appropriate power or a procedural requirement has not been complied with. Any such application to the High Court must be made not later than the end of the period of six weeks from the date of adoption of the SCI (i.e. six weeks from 21 July 2010).

Any person aggrieved by the SCI may apply to the High Court for permission to apply for judicial review of the decision to adopt the SCI. Any such application must be made promptly and in any event not later than three months after the day on which the SCI was adopted (i.e. three months after 21 July 2010).
