The Urban Design Guide SPD(s) comprises a series of documents:

- The Urban Design Guide;
- The Residential Design Guide; and
- The Public Realm Design Guide.

The guidance has been prepared through joint-working by the four partners identified above. Oldham MBC has adopted the series of documents as one Supplementary Planning Document. Rochdale MBC has adopted the document as a series of the separate SPDs.

An Equalities Impact Assessment (EqIA) of the draft Urban Design Guide SPD(s) was undertaken by the Oldham Metropolitan Borough Council and Rochdale Metropolitan Borough Council. It was subject to consultation from 9<sup>th</sup> March 2007 to 20<sup>th</sup> April 2007. One comment was received on the EqIA. A schedule of the comments received to the draft SPD and supporting documents, together with the Councils responses, can be found in the Consultation Statement accompanying the adopted Urban Design Guide SPD(s). The findings of this draft EqIA are still appropriate and therefore it is not considered necessary to undertake a new EqIA for the Urban Design Guide SPD(s).
