A person aggrieved by the plan who desires to question its validity on the ground that it is not within the powers conferred by Part II of the Town and Country Planning Act 1990 or that any requirement of that Act or any regulation made under it has not been complied with in relation to the adoption of the plan, may, within six weeks from 14 July 2006, make an application to the High Court under section 287 of the 1990 Act.
