This notice takes effect on 1st August 2005 when all the activity specified in this notice shall cease.



ANNEX

It is an offence to contravene a stop notice after a site notice has been displayed or the stop notice has been served on you. (Section 187(1) of the 1990 Act). If you fail to comply with the stop notice you will be at risk of immediate prosecution in the Magistrates Court for which the maximum penalty £20,000 on summary conviction is for a first offence and for any subsequent offence. The fine on conviction on indictment is unlimited. If you are in any doubt about what this notice requires you to do, you should get in touch immediately with Elizabeth Frier on 0161 911-4837. If you need independent advice about this notice you are advised to contact urgently a lawyer, planning consultant or other professional adviser specialising in planning matters. - 1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been breach of planning control, under section 171A(1)(a) of the above Act, at the land described below. They consider that it is expection to issue this notice, having regard to the provisions of the development plan and to other material planning considerations.
- 2. THE LAND AFFECTED

128 Rochdale Road, Royton, Oldham shown edged red on the attached plan ("the land").

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without planning permission, change of use, of the land from dwellings to café/restaurant and hot food takeway.

4. REASONS FOR ISSUING THIS NOTICE

It appears to the Council that the above breach of planning control has occurred within the last 10 years. The proposed change of use to a café/restaurant and hot food takeway at ground floor would, by reason of the level of activity likely to be generated by the use especially during the evenings, create significant levels of noise and disturbance, cooking odours and litter which would adversely affect the amenities of the occupiers of nearby residential properties. The proposal would therefore be contrary to Policy S1.6 of the Adopted Unitary Development Plan.

The additional on-street parking and manoeuvring of vehicles generated by this development within the Rochdale Road highway and other nearby highways will be detrimental to the safety of other highway users. The proposal would therefore be contrary to Policy S1.6 of the Adopted Unitary Development Plan.

5. WHAT YOU ARE REQUIRED TO DO

Permanently cease the unauthorised use of 128 Rochdale Road, Royton, Oldham as a café/restaurant (Class A3) Use Classes Order 2005 and a hot food takeway (Class A5) Use Classes Order 2005.

Time for Compliance: Takes place on the day this notice takes effect.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 26th August 2005 unless an appeal is made against it beforehand.

WHAT HAPPENS IF YOU DO NOT APPEAL


