

OLDHAM BOROUGH COUNCIL

HIGHWAYS ACT 1980

Oldham Borough Council in exercise of its power under Section 129A of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order;-

1. Except as provided in Article 2 to this Order no person shall use the public right of way over the highway ("the Highway") shown edged black on the plan annexed to this Order and described in columns 1 and 2 of the Schedule to this Order at any time.
2. The restriction in Article 1 to this Order shall not apply to any person who lives in premises adjoining the Highway or to any police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertakers, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highway.
3. Gates may be installed, operated and maintained at each end of the Highway. The Community Safety Unit of the Council is responsible for maintaining the gates and their contact number is 0161 770 3000.
4. The alternative route for pedestrians and vehicular traffic (if appropriate) during the period the Highway is restricted as described in column 3 of the Schedule to this Order and shown by a dotted line on the plan annexed to this Order.
5. This Order shall take effect on the 10th October 2007.

For access to footpath number 6 and 9 Lees: Dowry Road, Stamford Road and Redwood Lane
Part of footpath number 9 Lees from the rear of 1 Kingsley Drive between Redwood Drive	Extending from Redwood Lane between 15 Redwood Lane and 1 Kingsley Drive into Lees Park	For park access and for through route which used footpath number 7 Lees: Redwood Lane,

For access to footpath number 6 and 9 Lees: Kingsley Drive and Redwood Lane
Parts of footpaths 6, 8 and 9 Lees within Lees Park	These parts of the footpath extend from the respective park entry points and join to the other footpaths	These parts of the footpaths could be used as part of through movements, the alternative routes are as described in the entry for the adjacent section of the footpaths above

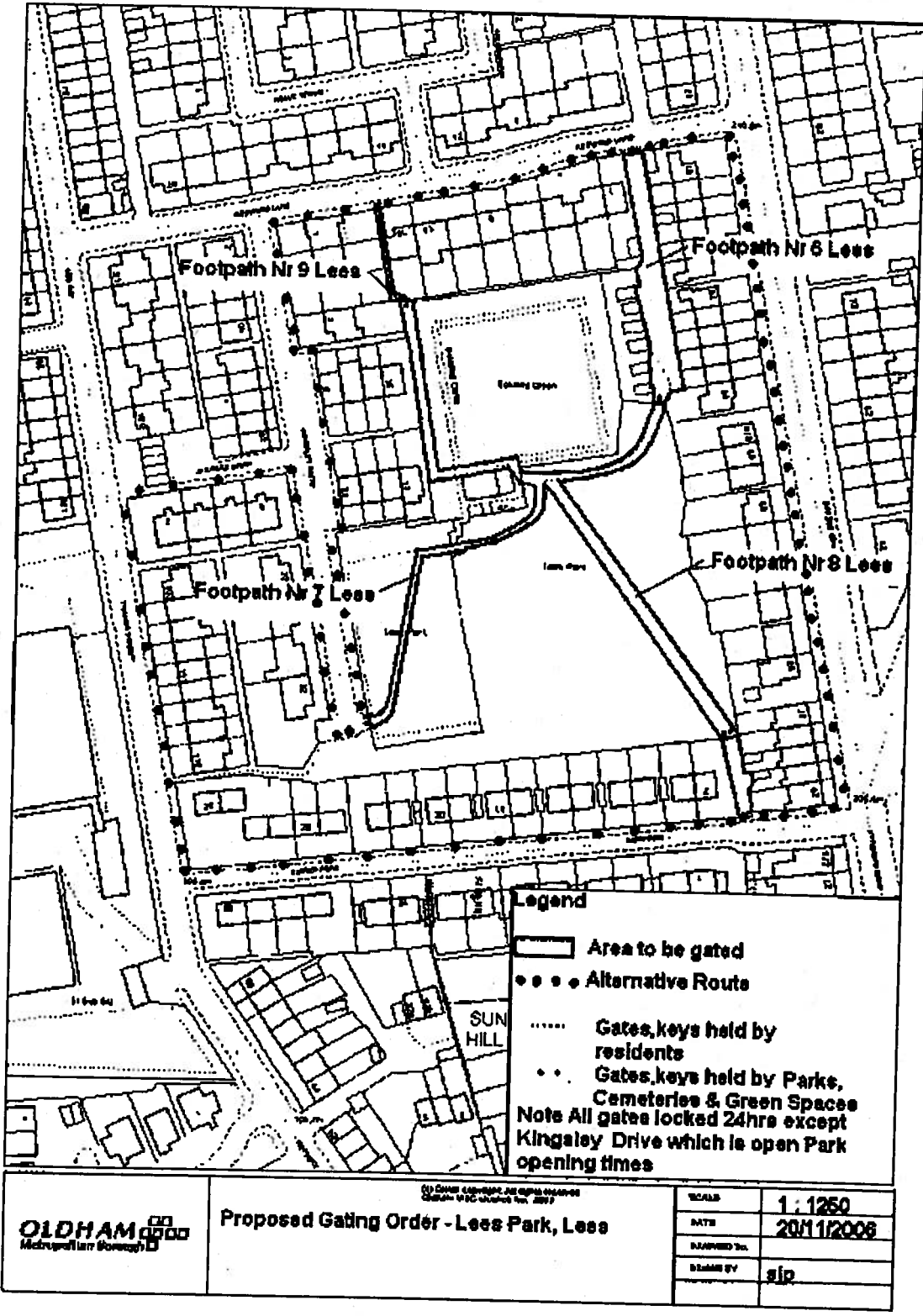

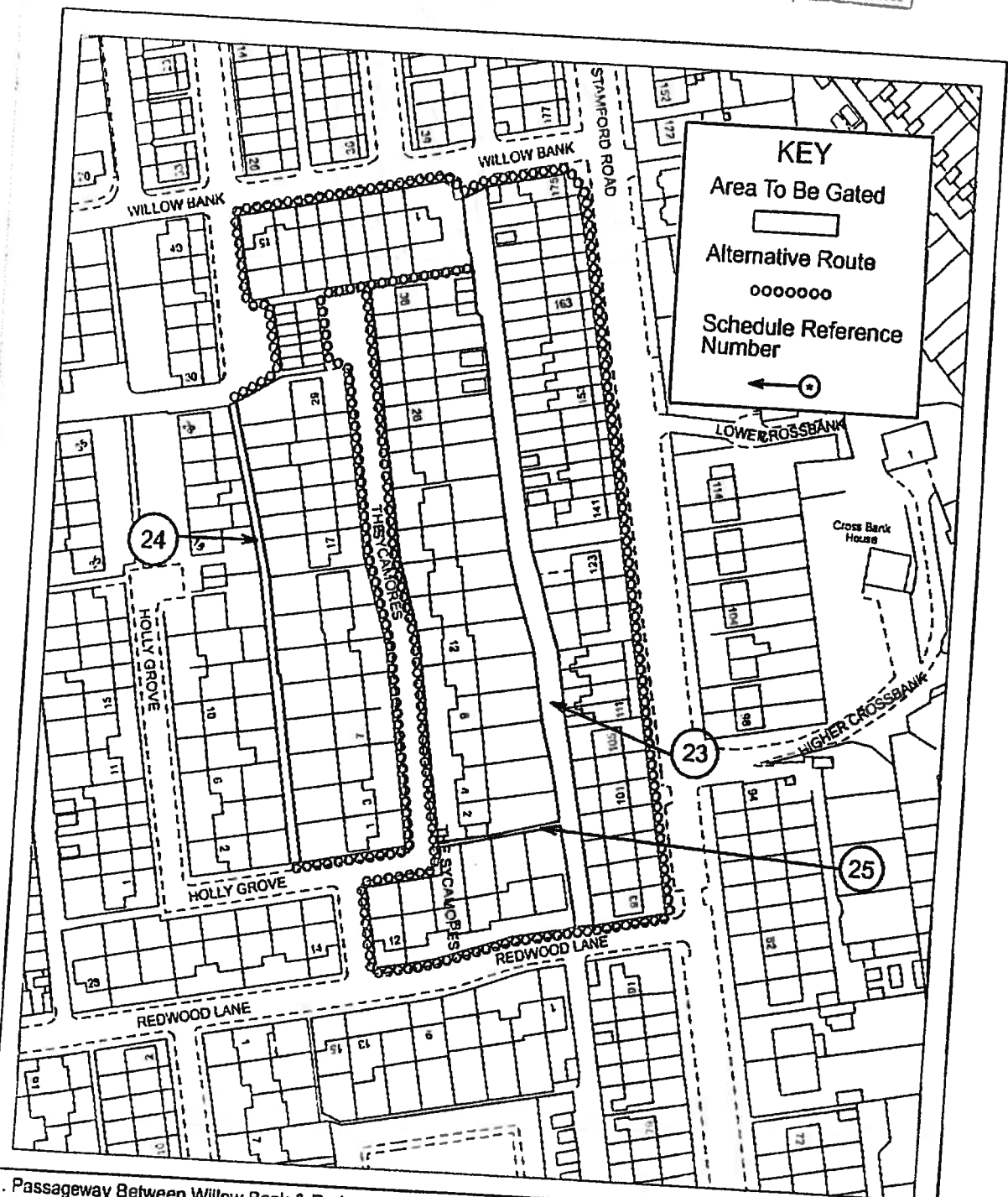
