## What this privacy notice is for

## What we use your information for

We collect or obtain your personal information for the following purpose(s):

- To ensure effective partnership working is in place and we maintain business continuity and safety for the people of Oldham.
- To ensure compliance with a statutory requirement in support of meeting the requirements of the Civil Contingencies Act 2002.
- To improve service performance

## What categories of personal information we use

Personal information can be anything that identifies and relates to a living person. This can include information that when linked with other information, allows a person to be uniquely identified. For example, this could be your name and contact details.

The law treats some types of personal information as 'special' because the information requires more protection due to its sensitivity. This information consists of:

- Racial or ethnic origin
- Sexuality and sexual life
- Religious or philosophical beliefs
- Trade union membership
- Political opinions
- Genetic and bio-metric data
- Physical or mental health
- Criminal convictions and offences

In order to carry out these purposes we collect and obtain the following personal information.

Personal/Business Details (eg. name, address and contact details)	No
Physical or mental health	Yes
Demographic (financial information)	Yes
Racial or ethnic origin	Yes
Religious or philosophical belief	Yes

## Legal basis for processing

The legal basis for processing and or sharing your personal information is:

- Where we have a legal obligation or it is in the public or our legitimate interest
- Marketing purposes: where we have asked and you have consented to receive electronic marketing information about our services (you may withdraw your consent at any time)
- If you fail to provide certain information when requested, we may not be able to perform the contract we have entered into with you

## Information sharing/recipients

We may share personal information about you with the following organisations:

- Local Fire authority
- Environment Agency
- Statutory undertaker and other public bodies eg. Water authority
- Health and Safety Executive
- Other parts of the Council
- Providers of goods and services
- Other Local Authorities
- Police Authority
- Fire Service
- North West Ambulance service
- Public Health England
- Central Government

As well as information collected directly from you, we also obtain or receive information from:

- Other parts of the Council
- Partners and other public bodies
- Central Government

## **Data Transfers beyond European Economic Area**

We do not transfer any of your personal information outside the European Economic Area ('EEA').

## **Automated Decisions**

All the decisions we make about you involve human intervention.

## **How long we keep your data**

We will only keep your personal information for as long as the law specifies or where the law does not specify this, for the length of time determined by our business requirements.
