PUBLIC SPACES PROTECTION ORDER 2018

Oldham Borough Council ("the Council") in exercise of its power under section 59 of the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act") and of all other enabling powers being satisfied that the conditions set out in section 59 of the Act have been met hereby makes the following Order:-

1. This Order applies to that part of the public place known as Royton town centre shown edged in red on the plan annexed to this Order ("the Restricted Area").
2. A person shall be guilty of an offence if they deposit waste, or leave any other article in the Restricted Area, in any place other than a waste bin or receptacle designated for the disposal of waste items.
3. A person shall be guilty of an offence if they do not comply with an instruction given by a Police Officer or other Authorised Person, not to consume alcohol or to surrender alcohol or a container for alcohol, within the Restricted Area.
4. A person shall be guilty of an offence if they remove any glass containers or glass bottles from any premises located within the Restricted Area which holds a premises licence issued under the Licensing Act 2003 for the supply of alcohol for consumption on the premises.
5. A person shall be guilty of an offence if they climb up, or onto any structure, including but not limited to, buildings, fire escapes, clothing bins and waste bins within the Restricted Area.
6. A person shall be guilty of an offence should they be found to be in possession of nitrous oxide containers or any other psychoactive substance within the Restricted Area.
7. For the purpose of Article 3 "Authorised Person" means a person authorised by the Council for the purposes of section 63 of the Act (Consumption of alcohol in breach of prohibition in order).
8. For the purposes of Article 4 a person who is lawfully employed by licensed premises who is removing a glass container or glass bottle from licensed premises for the purpose of placing it within the premises' own commercial waste receptacle shall not be guilty of an offence.

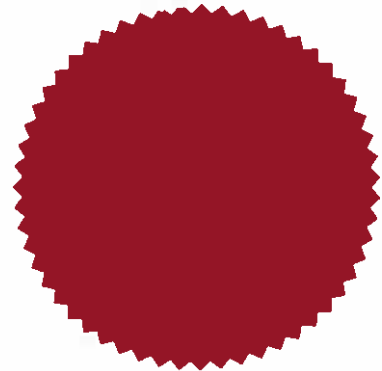
9. For the purpose of Article 5, a person who climbs on any structure with the consent of the owner of the structure shall not be committing an offence.
10. Any person who, without reasonable excuse, fails to comply with the requirements of Articles 2, 3, 4, 5 or 6 of this Order commits an offence and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale.

This Order shall come into force on 1 August 2018 for a period of three years.

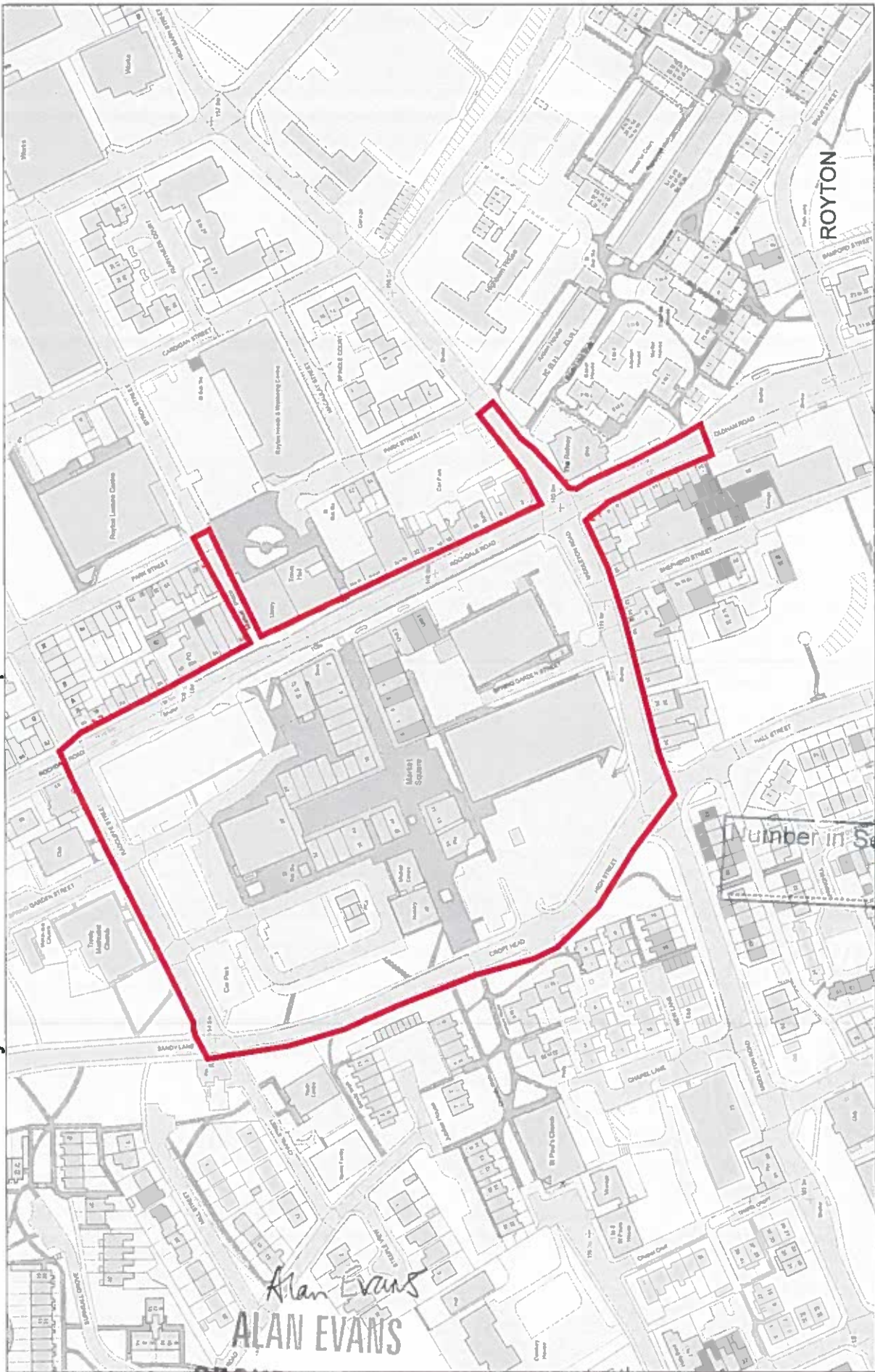
