### The SEND Review

The government has announced the launch of a crosscutting review of SEND. Five years on from the Children and Families Act, the review will look at the how the system has evolved since then, how it can be made to work best for all families and ensure quality of provision is the same across the country. Recognising the importance of joined-up support, it will also explore the role of health care in SEND in collaboration with the Department of Health and Social Care. The review will consider:

- the evidence on how the system can provide the highest quality support that enables children and young people with SEND to thrive and prepare for adulthood, including employment;
- how to better help parents to make decisions about what kind of support will be best for their child;
- how to make sure support in different local areas is consistent and joined up across health, care and education services, as well as ensuring that highquality health and education support is available across the country;
- how we strike the right balance between state-funded provision across inclusive mainstream and specialist places;
- how we align incentives and accountability for schools, colleges and local authorities to make sure they provide the best possible support for children and young people with SEND;
- what is behind the rise in education, health and care (EHC) plans and the role of specific health conditions in driving demand; and,
- how we ensure that public money is spent in an efficient, effective and sustainable manner, placing a premium on securing high quality outcomes for those children and young people who need additional support the most.

It will conclude with action to boost outcomes and improve value for money, so that vulnerable children have the same opportunities to succeed, as well as improving capacity and support for families across England.

## Extension of national Trial to extend powers of SEND tribunal to 31 August 2020

In April 2018, the Department for Education began a national Trial to extend the powers of the SEND Tribunal to hear appeals, and make non-binding decisions about, health and social care aspects of Education, Health and Care plans. The Trial was due to end on 31 March 2020. The Department is extending the Trial until 31 August 2020 and we have today written to Directors of Children's Services to inform them and provide further details. ### Supporting children and young people with asthma and/or severe allergies

Set out below is information about supporting children with asthma and/or severe allergies. This information will be of interest to all schools and many people working in other educational or linked institutions and organisations such as colleges and early years settings. Please make sure you share this guidance with your colleagues and through your networks to help raise awareness of the options available.

### Asthma emergency inhalers

Schools can buy salbutamol inhalers, without a prescription, for emergency use on children who have asthma but whose own device is not available or not working. The guidance gives schools that choose to keep an emergency inhaler the basis to create a policy or protocol for using it. ### Managing the risks of anaphylaxis

We have recently published practical advice, including resources to help schools manage allergy risks. One of the steps that schools can take is to buy adrenaline auto-injector (AAI) devices from a pharmacist (without a prescription) for emergency use on children who are at risk of anaphylaxis but whose own device is not available or not working. The guidance advises schools on the supply, storage, care and disposal of AAIs, including ensuring on a monthly basis that:

- AAIs are present and in date; and,
- replacement AAIs are obtained when expiry dates approach.

# NatSIP (the National Sensory Impairment Partnership) updated guidance on public examination access for children and young people with sensory impairments

This updated guidance is to help teachers of children and young people with hearing impairment (HI), vision impairment (VI) and multi-sensory impairment (MSI) understand the key principles underpinning reasonable adjustments for public examinations and the main access arrangements that may be appropriate for candidates with sensory impairment. It also includes examples of specialist reports written to support applications for access arrangements. Much of the content can be applied to all forms of summative assessment, but the primary focus of the guide is on general qualifications, i.e. GCSE and A level.

### Primary school nasal spray flu vaccination

As you may know, this autumn term, for the first time, all primary school aged children in England will be offered the nasal spray flu vaccination. This vaccination programme helps to protect children against flu, which can be a very unpleasant illness and lead to complications like bronchitis and pneumonia.

Public Health England has issued a briefing for schools to explain the flu vaccination programme for 2019/20, as well as template letters to send to parents to obtain their consent. ### Supporting governors and academy trustees in their role in relation to SEND: strategic use of data

In September we published an update of Understanding your data; a guide for school governors and academy trustees. The resource provides a basis for board discussions through the strategic use of data to ensure that value for money is achieved, whilst focusing on educational outcomes.

Some of the key changes generally are that we:

- re-published the resource in a more accessible version
- improved all sections, adding further clarity on messaging
- included links to additional sources of information, including guidance on setting executive salaries and academy trust good practice guides on internal scrutiny and management letters
