Purpose of the CAAMP SPD

Oldham Council Joint Core Strategy and Development Management Policies Development Plan Document (the 'Joint DPD'), known as the Local Plan, was adopted in November 2011.

The council is now preparing a Conservation Area Appraisal and Management Plan (CAAMP) Supplementary Planning Document (SPD) for the Oldham Town Centre Conservation Area. The SPD will provide further guidance on the relevant policies contained within the Joint DPD, in particular it will assist council officers and applicants in implementing Policy 24 'Historic Environment' in planning decisions and enforcement.

There is also a need for up to date evidence to inform the Local Plan review and its implementation when adopted. In addition to which the Oldham Town Centre CAAMP SPD will support the preparation of regeneration plans for the town centre.

The Oldham Town Centre CAAMP SPD is seen as a high priority as the conservation area has been surveyed as part of the Historic England Heritage at Risk Assessment. Following this assessment, the conservation area has been included on the conservation area "at Risk" Register. An up to date CAAMP is required in order to re-assess the designated area and evaluate and record its special interest. The last conservation area appraisal for Oldham Town Centre was published in April 1997.

A key aim for the Local Plan is to conserve and enhance Oldham's heritage and landscapes.

The SPD is made up of an appraisal which proposes to extend the existing conservation area boundary. The appraisal also identifies buildings that could be added to a local list¹.

The SPD then includes a management plan, which sets out policies and recommendations around enhancement, regeneration and community engagement.

The Oldham Town Centre CAAMP SPD serves to:

- Stimulate interest in both the protection of and careful development of Oldham Town Centre Conservation Area for present and future generations;
- Encourage wider use and enjoyment of assets within Oldham Town Centre;
- Encourage the conservation, repair, reuse and management of the area's historic features; and

- Work towards removing the conservation area from the “At Risk” register.

Planning and Compulsory Purchase Act 2004 and the Town and Country Planning Regulations 2012

The Planning Act 2008 and the Town and Country Planning (Local Planning) (England) Regulations 2012 removed the requirement to prepare a Sustainability Appraisal report for SPDs.

However, the council is still required to screen SPDs to ensure that the legal requirements for sustainability appraisals are met where there are impacts that have not been covered in the appraisal of the parent Development Plan Document (DPD) or where an assessment is required by the Strategic Environmental Assessment (SEA) Directive.

This determination statement therefore screens the Oldham Town Centre CAAMP SPD to ensure legal requirements are met.

European Directive 2001/42/EC and The Environmental Assessment of Plans and Programmes Regulations 2004

The European Directive 2001/42/EC requires a formal environmental assessment of certain plans and programmes which are likely to have significant effects on the environment. This applies to plans and programmes whose preparation began on or after 21 July 2004.

Where plans are subject to the Directive the responsible authority (Oldham Council) must prepare a report on its likely significant effects, consult environmental authorities and the public and take the report and the results of the consultation into account during the preparation process.

The Directive requires the council to determine whether or not the plan is likely to have significant environmental effects. The Directive and the Environmental Assessment of Plans and Programmes Regulations 2004 set out the determinations of the responsible authority.

The Environmental Assessment of Plans and Programmes Regulations 2004 Part 2 Regulation 9

Regulation 5 (6) sets out that an environmental statement does not need to be carried out for a plan relating to town and country planning or land use for a small area at a local level unless it has been determined under regulation 9(1) that the plan is likely to have significant environmental effects.

Under Regulation 9 (1), where a plan for which the first formal preparatory act is after 21 July 2004 and where the plan sets the framework for future development consent of projects, the Council must determine whether the plan is likely to have significant environmental effects.

Under Regulation 9 (2), before making a determination under Regulation 9(1), the Council shall take into account the criteria specified in Schedule 1 to the Regulations and consult the following three consultation bodies on the statement of its reasons for the determination:

- Environment Agency,
- Natural England; and
- Historic England.

Schedule 1 sets out the criteria for determining the likely significant effects on the environment.

Considering Part 2 Regulation 9

Regulation 9 (1) (a)

Preparation of the Oldham Town Centre CAAMP SPD began after 21 July 2004.

The SPD will support the implementation of the joint Core Strategy and Development Management Development Plan Document (the 'Joint DPD'). It will provide further guidance on the relevant policies within the Joint DPD. The Joint DPD itself sets the framework for future development consent of projects. The Joint DPD has been subject to a Sustainability Appraisal, incorporating the requirements of the Strategic Environmental Assessment Directive. The SPD will provide more detail on that adopted framework.

It will also inform the Local Plan review and Oldham Town Centre regeneration plans.

Regulation 9 (1) (b)

The SPD relates to Oldham Town Centre Conservation Area, the boundary of which it is proposing to extend. It is considered the SPD relates to the use of a small area at a local level and relates to town and country planning and land use.

The Oldham Town Centre CAAMP SPD is subject to a Habitats Regulations Assessment (HRA) screening opinion. The HRA Screening Opinion confirms that the implementation of the Oldham Town Centre CAAMP will have no likely significant effects on European sites and will not affect the integrity of any European sites designated for their nature conservation value. The Plan can be 'screened out' and no further level of Assessment is required.

Regulation 9 (1) (c)

The SPD does not concern a minor modification to a plan or programme and therefore Regulation 9 (1) (c) is not relevant.

Regulation 9 (2)

Regulation 9 (2) requires that the council considers the criteria specified in Schedule 1 before making a determination on whether the SPD is likely to have significant environmental effects.

Consultation

Regulation 9 (2) (b) requires consultation to be undertaken with the Environment Agency, Natural England and Historic England before making a determination.

The above consultation bodies were consulted between 13 December 2018 and 11 January 2019. Historic England and Natural England agreed that the Oldham Town Centre CAAMP SPD does not require a SEA and the Environment Agency stated they have no comments to make.

Under Regulation 11 (1) the Council will send to each of the three consultation bodies a copy of the determination within 28 days of making a determination and under Regulation 11 (2) the Council will keep a copy of the determination available at the principal office for inspection by the public and will take appropriate steps to bring the determination to the attention of the public within 28 days of making a determination.

Determination

The Council considers that after having regard to the Environmental Assessment of Plans and Programmes Regulations 2004 the Oldham Town Centre CAAMP SPD does not require a Strategic Environmental Assessment (SEA). The likely effects are expected to be positive.
