In addition, a number of Business Employment Areas (BEAs) that form part of this policy have been screened in as they could result in increased road traffic resulting in increases in air pollution. Hollinwood Business District; Wrigley Street and Greengate / Broadgate BEAs are also close to the Rochdale Canal SAC (within 200m) and development could result in direct impacts on the Canal.
