The policy scored mostly a mixture of positives and neutrals. However, it did score potentially negative / uncertain in terms of i) protecting, conserving and enhancing a high quality multifunctional green infrastructure network; ii) promoting quality and accessible open spaces; and iii) protecting and improving soil quality, best and most versatile agricultural land, and remediating contaminated land, as there are potential allocations identified which includes areas of open space or greenfield land in whole or part. Mitigation is included within policy CO1 of the Plan in terms of addressing and compensating for the loss of open spaces to development. As such, no mitigation or enhancement to the policy was required at this stage.

The policy has been screened in by the HRA as additional houses could result in increases in population, resulting in increased air pollution (from road traffic) and recreational disturbance effects. The HRA identifies mitigation measures to address likely significant effects.
